Year 10 BTEC Dance Coursework Assessments

I am writing to provide you with information on the externally set, internally completed coursework your child will complete for BTEC Dance in the coming weeks.

Over the course of Year 10 and Year 11 your child will complete three different components for BTEC Dance. The first component to be completed this academic year is Component 2 – *Developing skill and techniques in the Performing Arts*. This component is worth 30% of the BTEC Dance qualification. The coursework assessment window for Component 2 runs from *13 January* to *4 April 2025*. Most of the coursework will be completed during timetabled BTEC Dance lessons. There are additional sessions in place to support your child with the completion of this coursework highlighted below. If your child is entitled to any access arrangements for their exams then these will also be applied to all sections of the component throughout the assessment window.

Detailed below are the tasks for Component 2 with some context of what your child will be completing during this time.

After all the coursework has been completed it will be marked and moderated internally and then it will be sent to be externally moderated by the Pearson BTEC exam board. Your child will receive a raw mark out of 60 for Component 2 which will then be converted to a percentage to provide an overall assessment grade for each component (ranging from a Level 1 Pass to a Level 2 Distinction). Depending on how well students do across the country will determine where the component grade boundaries sit.

As previously mentioned above, all the coursework will be completed during this assessment window and it is crucial that your child remains focused and motivated in lessons. This will help to ensure that the work completed is to the best possible standard to help secure their overall grade. Any support and encouragement that can be provided at home would be incredibly beneficial to your child during this assessment period.
